## **CODE OF CONDUCT BAREFOOT BOWLS FOR MEMBERS, GUESTS AND VISITORS**

**Access to the club is a privilege and comes with certain rights and responsibilities.**

The Code of Conduct provides members, guests and visitors with guidance on the standards of behavior that are expected of them while they are on club premises and demonstrates the shared commitment by the club management and members, guests, and visitors in working together to achieve a social environment that enhances members, guests, and visitors' enjoyment of the club's facilities and services.

It has been developed by the club to ensure everyone can enjoy amenities provided by the club in a safe, enjoyable, and responsible manner.

Accordingly, members, guests and visitors shall:

- **Please respect the surface of the green. Throwing or dropping bowls is prohibited, as is running or jumping on the green. Footwear must be flat-soled, thongs, socks or barefoot. Heels of any sort are not allowed as they can damage the green.**
- We are a family-friendly Club, however parents are advised that they are responsible for the **supervision of their children at all times.** (There is to be no running on the greens) **Children Under 10 are not allowed on the Greens.**
- **Sunscreen is available** and guests are encouraged to wear hats and cover up when it's hot.
- **No Drinks to be taken on the Green.** We operate under the Responsible Service of Alcohol (RSA) regulations and all staff are RSA trained. Please don't be offended if service is refused (which can happen if staff judge that we will be in breach of the regulations if we continue to serve alcohol to an individual).
- **Offensive or abusive behaviour will not be tolerated**, nor will aggressive or destructive behaviour. Any person exhibiting these sorts of behaviours will be asked to leave the premises.
- **No Smoking on the green or surrounds**, however two smoking areas are set aside (staff on day will advise of the location).

The Code of Conduct is actively monitored by the club and applies at all times when members, guests and visitors are on the club premises.

If a breach occurs and can be proven, the club may ask you to leave and initiate disciplinary action, which may include refusal of entry, a verbal or written warning, withdrawal of certain privileges, suspension or termination of membership, and cost of repairs for malicious damage. The disciplinary action will be in accordance with the club's rules.
